- 2. **OEM Dealership certificate:** Bidders are requested to submit the Original Equipment Manufacturer (OEM) dealership certificate of the brand mentioned in the bid document.
- 3. **Technical Evaluation Criteria**: The bidders are requested to present the brand mentioned in the bid, which will be evaluated based on the following criteria.

- 4. **Evaluation of Stage 01:** The Stage 01 evaluation consists of technical evaluation and presentation of the bidders. The evaluation in stage 01 will be done as follows.
  - 1) The Technical Evaluation will be based on the parameters specified in the ToR and every bidder shall submit the documents accordingly for the evaluation criteria.
  - 2) The presentation evaluation will be based on the parameters specified aforementioned and every bidder shall present accordingly for the evaluation criteria.
  - 3) The total point scored in Technical Evaluation and presentation will be further evaluated and converted to 100% as follows. During the conversion 40% of Technical Bid evaluation and 60% of Presentation will be considered. Hence, this total point is said to be **point score in Stage 01 evaluation**.

4) The bidder who scored minimum of 75% shall proceed to Financial Evaluation. If all the bidders have scored less than 75%, the top three bidders shall proceed to Financial Evaluation.

#### **Notes:**

- ❖ The Bid Security for the project is 2% of the quoted amount as specified in Bidding Data Sheet.
- ❖ The minimum number of years of experience in the supply of goods and related services is **3 years** as specified in the **Bidding Data Sheet**.
