RICB would like to notify all eligible Bhutanese firms of the following changes to the eligibility criteria for the following:

LOT I - Supply, Delivery, Installation, Configuration and Commissioning of Core Routers, Firewalls, Core Switches and Access Switches for Data Center

9.13. Technical requirement for Lot I

1. Core Router Specifications

Original Requirement:

Must have minimum of 4 x 10 GE SFP+, 16 x 10/100/1000 GbE RJ45 (All ports can be configured as WAN and LAN), 4 Expansion slots

Amendment:

Must have minimum of 4 x 10 GE SFP+, 16 x 10/100/1000 GbE RJ45 (All ports can be configured as WAN and LAN), minimum of 2 Expansion slots

2. Core Switch Specifications

Original Requirement:

12 hardware queues per port

Amendment:

Minimum 8 hardware queues per port

3. Access Switch Specifications

Original Requirement:

IEEE802.3ad (LACP) with 128 LAGs per system and 8 ports per LAG

Number of ACL entries in hardware per system:2,000



IGMP snooping entries: 2000

IEEE802.3ad (LACP) with minimum of 16 LAGs per system and 8 ports per LAG

Number of ACL entries in hardware per system: minimum of 1,500

IGMP snooping entries: minimum of 1000

4. Next Generation Firewall Specification

Original Requirement:

The Firewall solution offered must be rated as '**Leader**' in the latest Magic Quadrant for Enterprise Firewall / NSS Lab

The appliance hardware should be a multicore CPU architecture with a hardened 64-bit operating system to support higher memory and minimum of 64 GB from day 1

Should support minimum 18 Gbps of NGFW throughput from day 1 or higher.

Amendment:

The Firewall solution offered must be rated as '**Leader**' in the latest Gartner Magic Quadrant for Enterprise Firewall

The appliance hardware should be a multicore CPU architecture with a hardened 64-bit operating system to support higher memory and minimum of 16 GB expandable to 64GB from day 1

Should support minimum 10 Gbps of NGFW throughput from day 1 or higher.

LOT II - Supply, Delivery, Installation, Configuration, and Commissioning of SAN storage solution
